THE 2025 LAURA B. MORRIS MICRO-GRANT

Dear Laura B. Morris Micro-Grant Awardee,

I hope this letter finds you well.

We are pleased to share that we are now accepting proposals for the 2025 Laura B. Morris (LBM) Micro-Grant. Established in 2022, this annual award supports a select group of small, Boston-based non-profit organizations—including grassroots groups and distinct initiatives housed within larger institutions. The grant provides funding of \$500 to \$2,000 to organizations that deliver meaningful services to elderly African American/Black women living in Boston with limited financial resources.

As you may recall, this grant honors two of our beloved members: Mrs. Laura B. Morris, who retired in 2022 after an extraordinary sixty-one years of service, and the late Mrs. Thelma Burns, whose advocacy inspired us to actively seek and support smaller or emerging organizations that serve our elders with creativity, dignity, and passion.

We invite you to apply for a 2025 LBM Micro-Grant, which may fund all or part of a new or ongoing activity, program, or service. Please note a change in our funding policy: organizations that received grants in 2022 are also eligible to apply this one last time! In 2026, we will return to our original policy of awarding no more than three micro-grants to eligible organizations. (In 2026, we will revert to our original policy which allowed organizations to apply for and receive a maximum of three micro-grants.)

The application process is pretty straightforward: complete the attached/enclosed form, including a brief description of your organization and details about the program or project you wish to begin, expand, or maintain. Please submit your completed application by September 19, 2025, via one of the following methods:

Also attached is our Grant Award Report Form. If your organization received a micro-grant in 2024, you are required to submit a report describing your use of the funds and outcomes.
